1 REPORT OVERVIEW

The report provides BDS estimates of production outputs for all ready-mixed concrete plants in Great Britain in 2020. It updates a similar analysis that we have prepared every year since 1990. It has been published at the same time of year as similar reports on asphalt and aggregates (land-won sand and gravel, marine sand and gravel and crushed rock).

Market volumes includes outputs for companies operating batching plants and truckmixers as well as those operating on-site batching vehicles (AKA MBP – mobile batching vehicles - often referred to as volumetric trucks, but can also include other truck variants). Estimates are presented in thousands of cubic metres (m³) for the calendar year 2020 and assigned to individual batching plants or, for the MBP sector, the depot at which trucks and materials are based. Also included are estimates for companies that operate collect-only services i.e. those that run one or more truckmixers but collect ready-mixed concrete from batching plants operated by other companies. (Figures for these companies are not added to the totals to prevent double-counting.)

This is the only source of industry information which provides an estimate of the market down to individual company and plant level. Efforts are made to ensure all ready-mixed concrete producers are included in the annual report. BDS monitors all of the 400+ planning authorities across Great Britain on an ongoing basis to identify new planning applications and decisions on already submitted schemes for batching plants and volumetric depots at new sites which provides one source to identify new sites and operators. Other sources of information include industry directories, Yellow Pages, industry bodies, news feeds and magazines and other research carried out by BDS on separate projects and reports. Every company is contacted by BDS researchers to verify status as well as being offered the opportunity to comment on outputs for the year. We have always had a good response from the industry when discussing our draft figures, which is much appreciated. Whilst a majority of companies contribute, we respect others that do not wish to participate.

1.1. Background & Purpose

The purpose of the report is to provide a detailed view of the performance of the ready-mixed concrete market in Great Britain. It provides information to individual plant level summarised by company, county, region and nationally and is designed to provide companies with market intelligence to support them in their operational and strategic objectives, whether they are ready-mixed concrete producers themselves or suppliers of plant, products and services. It is also vital material for industry observers and potential new investors into the industry.
